This Policy statement sets out the manner in which MLCO Trading Ltd process its client's and third party's personal information as well as the purpose for which the information is used.

Personal Information Processed

- **1.** Majority of the information which will be processed by MLCO Trading Ltd will be done for the purpose of carrying out actions or performance of a contract with the client or third party(example: Quotes, Invoices, Sales Order, Purchase orders etc.).
- **2.** Where information is not processed for the above-mentioned purpose, and/or where consent is required of the client or third party, it will be obtained, or personal information will only be processed where MLCO Trading Ltd is required by law to do so, it protects or is in pursuit of a legitimate interest.

Type & Usage of Personal Information

- **3.** The type of personal information which will be collected during the course of our operations and relationships with client's and third party's way include but is not limited to:
 - 3.1. Natural person Name & Surname or Juristic person Name;
 - 3.2. Identity, passport, company registration number or any other identifier
 - 3.3. Address (Including delivery address);
 - **3.4.** Representatives Details;
 - **3.5.** Contact details;
 - **3.6.** Banking Details
 - 3.7. Any other information required in order for us to fulfil our obligations to you.
- 4. The purpose for which the personal information will be used are (this is not an exhaustive list):
 - **4.1.** To process quote requests;
 - **4.2.** To process tender documents;
 - **4.3.** To process purchase orders;
 - **4.4.** To draft invoices or statements;
 - 4.5. To process credit applications;
 - **4.6.** To process deliveries;
 - **4.7.** To initiate legal proceedings;
 - **4.8.** To execute contracts etc.

Disclosure & Safeguarding of personal information
